25 (b.1) Board review.--The department may not publish any
26 proposed regulation or proposed general permit that regulates
27 agriculture or proposed technical guidance that affects
28 agriculture prior to:

29 (1) consultation with the board in the formulation of
30 the proposed regulation, proposed general permit or proposed
31 technical guidance, as reflected in the minutes or by written
32 comments of the board; or

1 (2) sixty days from the date when the proposed
2 regulation, proposed general permit or proposed technical
3 guidance was provided under subsection (a), unless the board
4 sooner decides by majority vote that no consultation under
5 paragraph (1) is required.
