14 section 5702 of Title 3 of the Pennsylvania Consolidated
15 Statutes is amended to read:

16 § 5702. Definitions.

17 The following words and phrases when used in this subchapter
18 shall have the meanings given to them in this section unless the
19 context clearly indicates otherwise:

21 "Potentially hazardous food." The term shall have the same
22 meaning as [defined in the 2009] time/temperature control for
23 safety food is defined in the 2022 edition of the Food Code
24 published by the [Department of Health and Human Services,]
25 United States Food and Drug Administration, or any successor
26 document approved by [regulation of] the department under
27 section 5707(e) (relating to powers of department).

8 Section 3. Section 5707(a) of Title 3 is amended and the
9 section is amended by adding a subsection to read:

10 § 5707. Powers of department.

11 (a) Rules and regulations.--The department shall make such
12 reasonable rules and regulations as may be deemed necessary for
13 carrying out the provisions and intent of this subchapter. In
14 promulgating regulations, the department shall be guided by the
15 [most current] 2022 edition of the Food Code, published by the
16 United States [Department of Health,] Food and Drug
17 Administration or any successor document approved by the
18 department under subsection (e). The regulatory standards
19 established by the department under this section shall be the
20 standards followed and applied by any licensor with respect to
21 retail food facilities.

23 (e) Adoption by reference.--

24 (1) The secretary shall review the 2022 edition of the
25 Food Code, published by the United States Food and Drug
26 Administration, and transmit notice to the Legislative
27 Reference Bureau for publication in the next available issue
28 of the Pennsylvania Bulletin of the standards approved for
29 adoption.

30 (2) The secretary shall review any subsequent changes to
31 the Food Code and shall transmit notice of adoption to the
32 Legislative Reference Bureau for publication in the next
33 available issue of the Pennsylvania Bulletin.
