AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as 1 reenacted, "An act relating to alcoholic liquors, alcohol and malt and brewed beverages; amending, revising, consolidating and changing the laws relating thereto; regulating and 5 restricting the manufacture, purchase, sale, possession, consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic 7 8 liquors, alcohol and malt and brewed beverages and the persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 licenses and regulations, further providing for wine auction 17 18 permits.
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. Section 408.12(a) of the act of April 12, 1951
- 22 (P.L.90, No.21), known as the Liquor Code, reenacted and amended
- 23 June 29, 1987 (P.L.32, No.14) and amended July 16, 2007
- 24 (P.L.107, No.34), is amended to read:
- 25 Section 408.12. Wine Auction Permits. -- (a) Upon application

- 2 (1) any nonprofit hospital;
- 3 (2) any nonprofit public television station which is a
- 4 member of the Pennsylvania Public Television Network;
- 5 (3) any orchestra located in a county of the first, second
- 6 or third class which is operated by a nonprofit corporation;
- 7 (4) any museum located in a county of the first, second or
- 8 third class which is operated by a nonprofit corporation;
- 9 (5) any nonprofit corporation located in any county of the
- 10 third class which trains and places dogs for people who are
- 11 physically handicapped;
- 12 (6) any nationally recognized community-based voluntary
- 13 health organization committed to fighting cancer which has been
- 14 in existence for at least ninety years;
- 15 (7) any nationally recognized emergency response
- 16 organization that offers humanitarian care to victims of war or
- 17 natural disaster and has been in existence for at least one
- 18 hundred twenty-five years;
- 19 (8) any nationally recognized organization whose purpose is
- 20 to serve as an agent to collect funds for local charities, as
- 21 well as to coordinate relief services, counsel and refer clients
- 22 to cooperating agencies and make emergency assistance grants and
- 23 has been in existence for at least one hundred twenty years;
- 24 [or]
- 25 (9) any hospice as defined under section 802.1 of the act of
- 26 July 19, 1979 (P.L.130, No.48), known as the "Health Care
- 27 Facilities Act"; or
- 28 (10) any college or university which is a member of the
- 29 Association of Independent Colleges and Universities of
- 30 Pennsylvania;

- 1 and upon payment of a fee of thirty dollars (\$30) per day, the
- 2 board shall issue a wine auction permit good for a period of not
- 3 more than four consecutive or nonconsecutive days per calendar
- 4 year.

- 6 Section 2. This act shall take effect in 60 days.
