## A JOINT RESOLUTION

- 1 Proposing integrated amendments to the Constitution of the
- 2 Commonwealth of Pennsylvania, further providing for
- legislative districts and for the Legislative Reapportionment
- 4 Commission for the purpose of reapportioning and
- 5 redistricting the Commonwealth of Pennsylvania.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby resolves as follows:
- 8 Section 1. The following integrated amendments to the
- 9 Constitution of Pennsylvania are proposed in accordance with
- 10 Article XI:
- 11 (1) That section 16 of Article II be amended to read:
- 12 § 16. Legislative and Congressional districts.
- 13 (a) The Commonwealth shall be divided into 50 senatorial and
- 14 203 representative districts, which shall be composed of compact
- 15 and contiguous territory as nearly equal in population as
- 16 practicable. Each senatorial district shall elect one Senator,
- 17 and each representative district one Representative. Unless
- 18 absolutely necessary no county, city, incorporated town,

- 1 borough, township or ward shall be divided in forming either a
- 2 senatorial or representative district. A county may not contain
- 3 more senatorial districts than the number required by the
- 4 population plus one. A county may not contain more
- 5 representative districts than the number required by the
- 6 population plus two. Senatorial and representative districts
- 7 <u>shall respect, where practicable, communities of interest.</u>
- 8 (b) Congressional districts shall each have a population as
- 9 close to the applicable ideal district population as possible.
- 10 To the extent consistent with equality of population,
- 11 congressional districts shall be composed of compact and
- 12 contiguous territory and, unless absolutely necessary, no
- 13 county, city, incorporated town, borough, township or ward shall
- 14 <u>be divided in forming congressional districts. Congressional</u>
- 15 districts shall respect, where practicable, communities of
- 16 interest.
- 17 (c) A legislative and congressional redistricting plan shall
- 18 not, as a whole, favor a specific person, political party or
- 19 political body.
- 20 (2) That section 17 of Article II be amended to read:
- 21 § 17. Legislative [Reapportionment] and Congressional
- 22 <u>Redistricting Commission.</u>
- 23 (a) [In each year following the year of the Federal
- 24 decennial census] Not later than December 31 of each year ending
- 25 <u>in zero</u>, a Legislative [Reapportionment] <u>and Congressional</u>
- 26 Redistricting Commission shall be constituted for the purpose of
- 27 [reapportioning] <u>redistricting</u> the Commonwealth. The commission
- 28 shall [act by a majority of its entire membership.]:
- 29 (1) Conduct an open and transparent process enabling full
- 30 public consideration of and comment on the drawing of district

- 1 lines.
- 2 (2) Draw district lines according to the redistricting
- 3 criteria specified in section 16.
- 4 (3) Conduct itself with integrity and fairness.
- 5 [(b) The commission shall consist of five members: four of
- 6 whom shall be the majority and minority leaders of both the
- 7 Senate and the House of Representatives, or deputies appointed
- 8 by each of them, and a chairman selected as hereinafter
- 9 provided. No later than 60 days following the official reporting
- 10 of the Federal decennial census as required by Federal law, the
- 11 four members shall be certified by the President pro tempore of
- 12 the Senate and the Speaker of the House of Representatives to
- 13 the elections officer of the Commonwealth who under law shall
- 14 have supervision over elections.
- 15 The four members within 45 days after their certification
- 16 shall select the fifth member, who shall serve as chairman of
- 17 the commission, and shall immediately certify his name to such
- 18 elections officer. The chairman shall be a citizen of the
- 19 Commonwealth other than a local, State or Federal official
- 20 holding an office to which compensation is attached.
- 21 If the four members fail to select the fifth member within
- 22 the time prescribed, a majority of the entire membership of the
- 23 Supreme Court within 30 days thereafter shall appoint the
- 24 chairman as aforesaid and certify his appointment to such
- 25 elections officer.
- Any vacancy in the commission shall be filled within 15 days
- 27 in the same manner in which such position was originally filled.
- 28 (c) No later than 90 days after either the commission has
- 29 been duly certified or the population data for the Commonwealth
- 30 as determined by the Federal decennial census are available,

- 1 whichever is later in time, the commission shall file a
- 2 preliminary reapportionment plan with such elections officer.
- 3 The commission shall have 30 days after filing the
- 4 preliminary plan to make corrections in the plan.
- 5 Any person aggrieved by the preliminary plan shall have the
- 6 same 30-day period to file exceptions with the commission in
- 7 which case the commission shall have 30 days after the date the
- 8 exceptions were filed to prepare and file with such elections
- 9 officer a revised reapportionment plan. If no exceptions are
- 10 filed within 30 days, or if filed and acted upon, the
- 11 commissions's plan shall be final and have the force of law.
- 12 (d) Any aggrieved person may file an appeal from the final
- 13 plan directly to the Supreme Court within 30 days after the
- 14 filing thereof. If the appellant establishes that the final plan
- 15 is contrary to law, the Supreme Court shall issue an order
- 16 remanding the plan to the commission and directing the
- 17 commission to reapportion the Commonwealth in a manner not
- 18 inconsistent with such order.
- 19 (e) When the Supreme Court has finally decided an appeal or
- 20 when the last day for filing an appeal has passed with no appeal
- 21 taken, the reapportionment plan shall have the force of law and
- 22 the districts therein provided shall be used thereafter in
- 23 elections to the General Assembly until the next reapportionment
- 24 as required under this section 17.
- 25 (f) Any district which does not include the residence from
- 26 which a member of the Senate was elected whether or not
- 27 scheduled for election at the next general election shall elect
- 28 a Senator at such election.
- 29 (q) The General Assembly shall appropriate sufficient funds
- 30 for the compensation and expenses of members and staff appointed

- 1 by the commission, and other necessary expenses. The members of
- 2 the commission shall be entitled to such compensation for their
- 3 services as the General Assembly from time to time shall
- 4 determine, but no part thereof shall be paid until a preliminary
- 5 plan is filed. If a preliminary plan is filed but the commission
- 6 fails to file a revised or final plan within the time
- 7 prescribed, the commission members shall forfeit all right to
- 8 compensation not paid.
- 9 (h) If a preliminary, revised or final reapportionment plan
- 10 is not filed by the commission within the time prescribed by
- 11 this section, unless the time be extended by the Supreme Court
- 12 for cause shown, the Supreme Court shall immediately proceed on
- 13 its own motion to reapportion the Commonwealth.
- 14 (i) Any reapportionment plan filed by the commission, or
- 15 ordered or prepared by the Supreme Court upon the failure of the
- 16 commission to act, shall be published by the elections officer
- 17 once in at least one newspaper of general circulation in each
- 18 senatorial and representative district. The publication shall
- 19 contain a map of the Commonwealth showing the complete
- 20 reapportionment of the General Assembly by districts, and a map
- 21 showing the reapportionment districts in the area normally
- 22 served by the newspaper in which the publication is made. The
- 23 publication shall also state the population of the senatorial
- 24 and representative districts having the smallest and largest
- 25 population and the percentage variation of such districts from
- 26 the average population for senatorial and representative
- 27 districts.]
- 28 (b) The commission shall consist of 11 members, as follows:
- 29 four who are registered with the largest political party in this
- 30 Commonwealth based on registration, four who are registered with

- 1 the second-largest political party in this Commonwealth based on
- 2 registration and three who are not registered with either of the
- 3 two largest political parties in this Commonwealth based on
- 4 <u>registration</u>.
- 5 (c) Each commission member shall possess all of the
- 6 following qualifications:
- 7 (1) Be a voter who has been continuously registered in this
- 8 Commonwealth with the same political party or unaffiliated with
- 9 <u>a political party or political body and whose political</u>
- 10 <u>affiliation has not changed in the previous three years</u>
- 11 <u>immediately preceding the date of appointment to the commission.</u>
- 12 (2) Has voted in two of the last three Statewide general
- 13 <u>elections immediately preceding the date of appointment to the</u>
- 14 <u>commission</u>.
- 15 (3) Has not held, nor has a spouse who has held, elective
- 16 public office at the Federal, State or political subdivision
- 17 level in this Commonwealth in the previous five years
- 18 immediately preceding the date of appointment to the commission.
- 19 <u>(4) Has not served as a paid staff member or paid consultant</u>
- 20 to Congress, the General Assembly, the Commonwealth or any
- 21 political subdivision in this Commonwealth in the previous five
- 22 years immediately preceding the date of appointment to the
- 23 commission.
- 24 (5) Has not registered as a Federal, State or local lobbyist
- 25 <u>in this Commonwealth in the previous five years immediately</u>
- 26 preceding the date of appointment to the commission.
- 27 (6) Has not held office or served as a paid staff member for
- 28 a political party or political body in the previous five years
- 29 immediately preceding the date of appointment to the commission.
- 30 (7) Has not been nominated as a candidate for elective

- 1 office by a political party or political body or served as a
- 2 paid staff member or officer of a political party, political
- 3 body, political committee or political action committee in the
- 4 previous five years immediately preceding the date of
- 5 appointment to the commission.
- 6 (d) Application and selection of the members of the
- 7 <u>commission shall be subject to the following:</u>
- 8 (1) Application to serve as a member of the commission may
- 9 <u>be filed with, and on a form developed by, the Secretary of the</u>
- 10 Commonwealth indicating thereon evidence of his or her
- 11 qualifications as provided by this section.
- 12 (2) The Secretary of the Commonwealth shall verify the
- 13 qualifications of each applicant. If the Secretary of the
- 14 Commonwealth finds that an applicant is not qualified, the
- 15 <u>Secretary of the Commonwealth shall not include the applicant's</u>
- 16 <u>name in the pool of applicants.</u>
- 17 (3) The Secretary of the Commonwealth shall separate all
- 18 qualified applicants into three groups consisting of those who
- 19 are:
- 20 (i) registered with the largest political party in this
- 21 Commonwealth based on registration;
- 22 (ii) registered with the second-largest political party in
- 23 this Commonwealth based on registration; and
- 24 (iii) not registered with either of the two largest
- 25 political parties in this Commonwealth based on registration.
- 26 (4) The Secretary of the Commonwealth shall select, for
- 27 appointment as members of the commission under paragraph (3), on
- 28 a random basis from each of the three groups of qualified
- 29 <u>applicants</u>. In addition to the qualification requirements
- 30 provided in subsection (c), appointments from each group shall

- 1 reasonably reflect the racial, geographic and gender diversity
- 2 of this Commonwealth.
- 3 (5) One of the members shall be selected as chair by a vote
- 4 of at least six members of the commission.
- 5 (e) The term of office of each member of the commission
- 6 shall expire at the same time the commission expires as provided
- 7 in this section.
- 8 (f) Removal of a member and vacancies on the commission
- 9 shall be subject to the following:
- 10 (1) If a member of the commission fails to attend more than
- 11 two consecutive meetings at which a vote of the commission is
- 12 scheduled, the member's position shall be deemed vacant unless
- 13 the member is absent due to death of an immediate family member,
- 14 personal illness or illness of an immediate family member.
- 15 (2) A vacancy in the commission shall be filled within 14
- 16 days from the time the commission is notified of the vacancy in
- 17 the same manner that the position was originally filled and
- 18 using the same pool of applicants under subsection (d)(3) from
- 19 which the vacating member was chosen. If none of those remaining
- 20 applicants are available for service, the Secretary of the
- 21 Commonwealth shall fill the vacancy from a new pool of
- 22 applicants created for the same voter registration category as
- 23 the vacating member.
- 24 (q) A member shall be ineligible for a period of three years
- 25 beginning from the expiration of the term that the member was
- 26 appointed to the commission to:
- 27 (1) Hold an appointive State or political subdivision
- 28 position in this Commonwealth.
- 29 (2) Serve as a paid staff member or paid consultant to
- 30 Congress, the General Assembly, the Commonwealth or any

- 1 political subdivision.
- 2 (3) Register as a Federal, State or local lobbyist in this
- 3 Commonwealth.
- 4 (4) Hold office or serve as a paid staff member or paid
- 5 political consultant for a political party, political body,
- 6 political committee or political action committee.
- 7 (h) A member shall be ineligible for a period of five years
- 8 <u>beginning from the expiration of the term that the member was</u>
- 9 appointed to the commission to:
- 10 (1) Hold elective public office at the State or political
- 11 <u>subdivision level in this Commonwealth.</u>
- 12 (2) Be eligible for nomination as a candidate for elective
- 13 office by a political party or political body.
- (i) Seven members of the commission shall constitute a
- 15 quorum. Seven or more affirmative votes shall be required for an
- 16 official action. The final plan must be approved by at least
- 17 seven affirmative votes, which must include at least one vote of
- 18 a member registered from each of the two largest political
- 19 parties in this Commonwealth based on registration and one vote
- 20 from a member who is not registered with either of the two
- 21 largest political parties.
- 22 (j) To begin the process of preparing information necessary
- 23 to the redistricting process, the commission shall complete all
- 24 of the following:
- 25 (1) The commission shall acquire all necessary and
- 26 appropriate information, review and evaluate available
- 27 <u>facilities and develop programs and procedures, including the</u>
- 28 use of software, in preparation for drawing a plan on the basis
- 29 of each Federal census. The commission shall make the
- 30 information available to the public through the commission's

- 1 publicly accessible Internet website.
- 2 (2) As soon as possible after December 31 of each year
- 3 ending in zero, the commission shall obtain from the United
- 4 States Census Bureau the population data needed for legislative
- 5 redistricting that the Census Bureau is required to provide the
- 6 Commonwealth under 13 U.S.C. § 141 (relating to population and
- 7 other census information) and shall use that data to assign a
- 8 population figure based upon census data to each geographic and
- 9 political unit described pursuant to subparagraph (i). Upon
- 10 completing that task, the commission shall begin the preparation
- 11 of a plan as required by this section and section 16. The
- 12 commission shall use the data obtained to prepare:
- (i) Necessary descriptions of census blocks, voting
- 14 districts, wards, municipalities and counties for which census
- 15 data will be reported and that are suitable for use as
- 16 <u>components of districts.</u>
- 17 (ii) Maps of census blocks, voting districts, wards,
- 18 municipalities and counties within this Commonwealth, that may
- 19 <u>be used to illustrate the locations of district boundaries</u>
- 20 proposed in a plan.
- 21 (k) Each plan shall provide that a vacancy in the General
- 22 Assembly that is filled under the plan, occurring at a time that
- 23 <u>makes it necessary to fill the vacancy at a special election</u>
- 24 held under section 629 of the act of June 3, 1937 (P.L.1333,
- 25 No.320), known as the Pennsylvania Election Code, shall be
- 26 filled from the same district that elected the senator or
- 27 <u>representative whose seat is vacant.</u>
- 28 (1) The commission, within 30 days prior to the deadline for
- 29 approval of a preliminary plan as provided in subsection (m)(1),
- 30 shall schedule and conduct at least four public hearings in

- 1 different geographic regions of this Commonwealth.
- 2 (m) (1) Not later than July 1 of each year ending in one,
- 3 the commission shall complete and approve a preliminary plan and
- 4 maps as required under this section and make a preliminary plan
- 5 and maps available to the public through the commission's
- 6 publicly accessible Internet website.
- 7 (2) The commission, within 30 days following the deadline
- 8 for approval of a preliminary plan as provided in paragraph (1),
- 9 <u>shall schedule and conduct at least four public hearings, in</u>
- 10 different geographic regions of this Commonwealth, on the
- 11 preliminary plan.
- 12 (3) Not later than August 15 of each year ending in one, the
- 13 commission shall approve a final redistricting plan. Upon
- 14 approval, the commission shall certify the resulting plan to the
- 15 Secretary of the Commonwealth, and that plan shall constitute
- 16 the certified final plan.
- 17 (4) If the commission fails to approve a final plan in
- 18 <u>accordance with paragraph (3), the following shall apply:</u>
- 19 (i) Not later than September 1 of each year ending in one,
- 20 the commission shall complete and approve a second preliminary
- 21 redistricting plan and maps prepared in accordance with this
- 22 section and section 16 and make a second preliminary plan and
- 23 maps available to the public through the commission's publicly
- 24 accessible Internet website.
- 25 (ii) Within 30 days following the deadline for approval of
- 26 the second preliminary plan as set forth in subparagraph (i),
- 27 the commission shall schedule and conduct at least four public
- 28 hearings, in different geographic regions of this Commonwealth,
- 29 on the second preliminary plan.
- 30 (iii) Not later than October 15 of each year ending in one,

- 1 the commission shall approve a final redistricting plan. Upon
- 2 approval, the commission shall certify the resulting plan to the
- 3 Secretary of the Commonwealth, and that plan shall constitute
- 4 the certified final plan.
- 5 (n) If the commission does not complete and approve a final
- 6 plan by October 16 of each year ending in one, the Secretary of
- 7 the Commonwealth shall immediately petition the Supreme Court
- 8 for an order directing the appointment of a special master to
- 9 <u>develop and complete a final plan in accordance with the</u>
- 10 <u>criteria and requirements provided in this section and section</u>
- 11 16. The special master must demonstrate expertise in geographic
- 12 <u>information systems by holding a graduate degree in geographic</u>
- 13 <u>information systems and currently serving as a faculty member</u>
- 14 for a geographic information systems program at an institution
- 15 of higher learning located within this Commonwealth and must
- 16 meet the qualifications in subsection (c) and be bound by the
- 17 restrictions in subsections (q) and (h). Upon its approval of
- 18 the master's plan, the Supreme Court shall certify the resulting
- 19 plan to the Secretary of the Commonwealth, and that plan shall
- 20 constitute the certified final plan.
- 21 (o) The commission has the sole legal standing to defend an
- 22 action regarding a certified final plan and shall inform the
- 23 General Assembly if it determines that funds or other resources
- 24 provided for the operation of the commission are not adequate.
- 25 (p) (1) The Supreme Court has original and exclusive
- 26 jurisdiction in all proceedings in which a certified final plan
- 27 <u>is challenged or is claimed not to have taken timely effect.</u>
- 28 (2) An aggrieved person who is a registered voter in this
- 29 Commonwealth may file a petition with the Supreme Court within
- 30 30 days after the commission has certified a final plan to the

- 1 <u>Secretary of the Commonwealth to bar the Secretary of the</u>
- 2 Commonwealth from implementing the plan on the grounds that the
- 3 filed plan violates the Constitution of the United States, this
- 4 <u>Constitution or any Federal or State statute.</u>
- 5 (q) The Department of State shall provide staff as needed to
- 6 support the commission in the performance of its duties.
- 7 <u>(r) Upon the filing of all redistricting plans required</u>
- 8 <u>under this section and the exhaustion of all appeals of a</u>
- 9 <u>redistricting plan:</u>
- 10 (1) the commission shall expire and the commission's
- 11 <u>responsibilities shall terminate; and</u>
- 12 (2) the final plan shall have the force of law and the
- 13 <u>districts provided in the final plan shall be used thereafter in</u>
- 14 elections to the General Assembly until the next redistricting
- 15 as required under this section.
- 16 (s) The General Assembly shall appropriate sufficient funds
- 17 for the compensation and expenses of members and staff appointed
- 18 by the commission and for other necessary expenses. In addition
- 19 to necessary expenses, the members of the commission shall
- 20 receive a per diem for each day or part of a day spent
- 21 performing their official duties. The per diem shall be the most
- 22 recent per diem rate for locations in this Commonwealth as
- 23 established and published by the United States General Services
- 24 Administration.
- 25 (t) A district that does not include the residence from
- 26 which a member of the Senate was elected whether or not
- 27 <u>scheduled for election at the next general election shall elect</u>
- 28 a Senator at the election.
- 29 <u>(u) The following words and phrases when used in this</u>
- 30 section shall have the meanings given to them in this subsection

- 1 <u>unless the context clearly indicates otherwise:</u>
- 2 "Commission." The Legislative and Congressional
- 3 Redistricting Commission.
- 4 <u>"Federal census." The decennial census required by Federal</u>
- 5 law to be conducted by the United States Census Bureau in every
- 6 <u>year ending in zero.</u>
- 7 "Immediate family." A parent, spouse, child, brother or
- 8 sister.
- 9 "Member." A member of the Legislative and Congressional
- 10 Redistricting Commission.
- 11 "Plan." A plan for legislative and congressional
- 12 redistricting drawn under the requirements of this section and
- 13 section 16.
- 14 Section 2. (a) Upon the first passage by the General
- 15 Assembly of these proposed constitutional amendments, the
- 16 Secretary of the Commonwealth shall proceed immediately to
- 17 comply with the advertising requirements of section 1 of Article
- 18 XI of the Constitution of Pennsylvania and shall transmit the
- 19 required advertisements to two newspapers in every county in
- 20 which such newspapers are published in sufficient time after
- 21 passage of these proposed constitutional amendments.
- 22 (b) Upon the second passage by the General Assembly of these
- 23 proposed constitutional amendments, the Secretary of the
- 24 Commonwealth shall proceed immediately to comply with the
- 25 advertising requirements of section 1 of Article XI of the
- 26 Constitution of Pennsylvania and shall transmit the required
- 27 advertisements to two newspapers in every county in which such
- 28 newspapers are published in sufficient time after passage of
- 29 these proposed constitutional amendments. The Secretary of the
- 30 Commonwealth shall submit the proposed constitutional amendments

- 1 under section 1 to the qualified electors of this Commonwealth
- 2 as a single ballot question at the first primary, general or
- 3 municipal election occurring at least three months after the
- 4 proposed constitutional amendments are passed by the General
- 5 Assembly.
