AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school security, providing for
- school security personnel.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1316-C. School security personnel.
- 13 (a) School day. -- Notwithstanding any other provision of law,
- 14 beginning in the 2023-2024 school year, a school entity shall
- 15 have one armed school security personnel on duty during the
- 16 school day at each school building.
- 17 <u>(b) Extracurricular activities.--A governing body of a</u>
- 18 school entity may decide to have an armed school security
- 19 personnel on duty at the school campus during extracurricular
- 20 activities that occur outside of the school day.

- 1 (c) Certification. -- A school entity must certify to the
- 2 School Safety and Security Committee that an armed school
- 3 security personnel satisfies the requirements of this article.
- 4 (d) Powers and duties.--
- 5 (1) School police officers shall have the powers and
- 6 duties provided under section 1302-C.
- 7 (2) School resource officers shall have the powers and
- 8 <u>duties provided under section 1313-C.</u>
- 9 (3) School security guards shall have the powers and
- 10 <u>duties provided under section 1314-C.</u>
- 11 (4) School security personnel may have other duties as
- 12 <u>assigned by the school entity.</u>
- (e) Funding. -- Money allocated to the School Safety and
- 14 Security Fund for the School Safety and Security Grant Program
- 15 may be used for the requirements of this section.
- (f) Definitions.--As used in this section, the following
- 17 words and phrases shall have the meanings given to them in this
- 18 subsection unless the context clearly indicates otherwise:
- 19 "School campus." The grounds and buildings of a school that
- 20 is, or is part of, a school entity.
- 21 "School day." The hours between the morning opening of a
- 22 school building and the afternoon dismissal of students on a day
- 23 which classes are in session on the school campus.
- 24 Section 2. This act shall take effect in 60 days.
