AN ACT

Amending the act of November 30, 1965 (P.L.847, No.356), entitled "An act relating to and regulating the business of 2 banking and the exercise by corporations of fiduciary powers; 3 affecting persons engaged in the business of banking and 4 corporations exercising fiduciary powers and affiliates of 5 such persons; affecting the shareholders of such persons and 6 7 the directors, trustees, officers, attorneys and employes of such persons and of the affiliates of such persons; affecting 8 national banks located in the Commonwealth; affecting persons 9 dealing with persons engaged in the business of banking, 10 11 corporations exercising fiduciary powers and national banks; conferring powers and imposing duties on the Banking Board, 12 on certain departments and officers of the Commonwealth and 13 on courts, prothonotaries, clerks and recorders of deeds; 14 providing penalties; and repealing certain acts and parts of 15 acts," in general provisions, further providing for legal 16 holidays; and making a repeal. 17 18 The General Assembly of the Commonwealth of Pennsylvania 19 hereby enacts as follows: Section 1.
