AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for biennial registration of certain
- vehicles; and further providing for annual registration fees,
- for passenger cars and for trucks and truck tractors.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 1307.2. Biennial registration of certain vehicles.
- 10 The department may establish a system for renewing the
- 11 <u>vehicle registration of passenger cars, Class 1 trucks and Class</u>
- 12 2 trucks on a biennial basis to owners and lessees of the
- 13 vehicles and may promulgate rules and regulations to implement
- 14 the system.
- 15 Section 2. Sections 1911(a) and 1912 of Title 75 are amended
- 16 to read:
- 17 § 1911. Annual and biennial registration fees.
- 18 (a) General rule. -- An annual or optional biennial fee for

- 1 the registration of vehicles as provided in Chapter 13 (relating
- 2 to the registration of vehicles) shall be charged by the
- 3 department as provided in this title.
- 4 * * *
- 5 § 1912. Passenger cars.
- 6 (a) General rule. -- The annual fee for registration of a
- 7 passenger car shall be \$36.
- 8 (b) Optional biennial registration. -- A vehicle may be
- 9 registered for a period of two years upon payment by the
- 10 registrant of the applicable fee of \$72.
- 11 Section 3. Section 1916 of Title 75 is amended by adding a
- 12 subsection to read:
- 13 § 1916. Trucks and truck tractors.
- 14 * * *
- 15 (c) Optional biennial registration. -- A vehicle designated
- 16 Class 1 or Class 2 under this section may be registered for a
- 17 period of two years upon payment by the registrant of the
- 18 applicable fee of \$117 for Class 1 and \$162 for Class 2.
- 19 Section 4. This act shall take effect in 180 days.
