17	"Board of directors." The group of persons vested with the
18	management of the business and affairs of a nonprofit
19	organization irrespective of the name by which the group is
20	designated. The term does not include another body.
21	"Director." A person designated, elected or appointed, by
22	that or any other name or title, to act as a director, and his
23	successors. The term does not include a member of another body.
24	"Nonprofit organization." An entity listed under section
25	501(c)(3) of the Internal Revenue Code of 1986 (Public Law 99-

[Except as otherwise restricted in the bylaws, the board of directors of a nonprofit corporation shall have the authority to fix the compensation of directors for their services as directors, and a director may be a salaried officer of the corporation.] <u>A director may not receive compensation for</u> <u>services as a director.</u>
