AN ACT

- 1 Providing for marina health and safety.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the James
- 6 DeAngelo Marina Health and Safety Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "911 telephone." A telephone that does any of the following:
- 12 (1) Allows an individual using the telephone to contact
- a public safety answering point by dialing or pressing 911.
- 14 (2) Automatically calls a public safety answering point
- 15 when an individual picks up the handset and activates the
- 16 telephone.
- 17 "Appropriate signage." A sign posted in plain view by each

- 1 automated external defibrillator, panic button, 911 telephone
- 2 and personal security device with instructions for use.
- 3 "Automated external defibrillator." A portable device that
- 4 uses electric shock to restore a stable heart rhythm to an
- 5 individual in cardiac arrest.
- 6 "Emergency services." Services, including firefighting, law
- 7 enforcement, ambulance and medical services, provided for the
- 8 protection or preservation of persons or property in
- 9 circumstances of immediate and significant threat of injury or
- 10 harm.
- 11 "Marina." As follows:
- 12 (1) A dock or basin that provides secure moorings for
- small boats or pleasure watercraft.
- 14 (2) The term includes a clubhouse, building, facility or
- other structure that provides food, fueling, repair or other
- 16 services for the dock or basin.
- 17 "Marine and aquatic services." Services, activities,
- 18 privileges or rights offered for sale or provided by a marina.
- 19 "Nonstaffed hours." A period during which a marina provides
- 20 marine and aquatic services without an employee of the marina on
- 21 the premises.
- "Public safety answering point." As defined in 35 Pa.C.S. §
- 23 5302 (relating to definitions).
- 24 "Staffed hours." A period during which a marina provides
- 25 marine and aquatic services with at least one employee of the
- 26 marina on the premises.
- 27 Section 3. Duties of marina.
- 28 Each marina offering marine and aquatic services during
- 29 staffed hours and nonstaffed hours shall:
- 30 (1) Meet the requirements of the municipality in which

- 1 the marina is located concerning accessibility to emergency
- 2 services responders from outside the marina.
- 3 (2) Equip the premises of the marina with all of the
- 4 following:
- 5 (i) At least one automated external defibrillator.
- 6 (ii) Appropriate signage.
- 7 (iii) A 911 telephone.
- 8 (3) Provide instructions regarding the use of the marina
- 9 during nonstaffed hours, including the location and use of
- 10 all equipment.
- 11 Section 4. Effective date.
- 12 This act shall take effect in 60 days.
