- 1 Amending Title 40 (Insurance) of the Pennsylvania Consolidated
- Statutes, in preliminary provisions relating to health
- insurance markets oversight, further providing for
- definitions; and, in State-based exchange, further providing
- for powers and duties of exchange authority.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 9103 of Title 40 of the Pennsylvania
- 9 Consolidated Statutes is amended by adding a definition to read:
- 10 § 9103. Definitions.
- 11 Subject to additional definitions contained in subsequent
- 12 provisions of this part which are applicable to specific
- 13 provisions of this part, the following words and phrases when
- 14 used in this part shall have the meanings given to them in this
- 15 section unless the context clearly indicates otherwise:
- 16 "Affordability assistance program." The affordability
- 17 assistance program implemented by the exchange authority under
- 18 section 9305(b)(6) (relating to powers and duties of exchange

- 3 Section 2. Section 9305(b)(4) and (5) of Title 40 are
- 4 amended and the subsection is amended by adding a paragraph to
- 5 read:
- 6 § 9305. Powers and duties of exchange authority.
- 7 * * *
- 8 (b) Programmatic duties. -- The exchange authority shall
- 9 perform all duties necessary or appropriate to advance its
- 10 purpose, including the following:
- 11 * * *
- 12 (4) Assess and collect fees from on-exchange insurers to
- support the operation of the exchange under this chapter and
- 14 <u>either</u> the reinsurance program established under section
- 9502(b) (relating to implementation of waiver and
- 16 establishment of reinsurance program) or an affordability
- 17 assistance program as described in paragraph (6), or both,
- 18 except that the exchange authority may not assess or collect
- any form of obligation other than an exchange user fee on
- total monthly premiums for on-exchange policies and unless
- approved by unanimous consent of the board, the fee may not
- 22 exceed 3% of total monthly premiums for on-exchange policies.
- 23 In no case may the fee exceed 3.5%.
- 24 (5) Disburse receipted fees, including to benefit [the
- reinsurance program established under section 9502(b).]:
- 26 (i) the reinsurance program established under
- 27 section 9502(b);
- 28 <u>(ii) an affordability assistance program in plan</u>
- year 2025 as described in paragraph (6), provided that
- the commissioner determines that alternative funds are

1	available to fund the reinsurance program in a manner
2	that satisfies the requirements of the Commonwealth's
3	innovation waiver in accordance with section 1332 of the
4	Affordable Care Act and transmits notice of the
5	determination to the Legislative Reference Bureau for
6	publication in the next available issue of the
7	Pennsylvania Bulletin; or
8	(iii) both the reinsurance program under
9	subparagraph (i) and an affordability assistance program
10	under subparagraph (ii).
11	(6) Implement an affordability assistance program in
12	plan year 2025 to provide a net positive financial impact to
13	consumers of on-exchange qualified plans in this
14	Commonwealth. The following apply:
15	(i) The affordability assistance program shall be
16	designed to incentivize enrollment in on-exchange
17	policies based on income or other eligibility criteria.
18	(ii) The provision of money or benefits accrued
19	through the affordability assistance program may not
20	constitute an entitlement derived from the Commonwealth
21	or a claim on any other money of the Commonwealth.
22	(iii) The affordability assistance program shall be
23	subject to all provisions of this chapter pertaining to
24	the operations of the exchange authority and the exchange
25	fund, including sections 9310 (relating to audits) and
26	9311 (relating to reports).
