AMENDMENTS TO SENATE AMENDMENTS, HOUSE OF REPRESENTATIVES, NOVEMBER 18, 2019

AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school security, further providing for definitions, for school police officers, for training, for powers and duties, for school resource officers and for 7 school security guards; in high schools, further providing 8 for courses of study; in miscellaneous provisions relating to 9 institutions of higher education, further providing for 10 Public Higher Education Funding Commission; and, in fostering 11 independence through education, further providing for 12 13 fostering independence waiver program. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows:
- 16 Section 1. The definition of "school security guard" in
- 17 section 1301-C of the act of March 10, 1949 (P.L.30, No.14),
- 18 known as the Public School Code of 1949, amended July 2, 2019

- 21 The following words and phrases when used in this article

- 4 "School security guard." An individual employed by a school
- 5 entity, nonpublic school or a third-party vendor or an
- 6 independent contractor who is assigned to a school for routine
- 7 safety and security duties and has not been granted powers under
- 8 section [1306-C(3)] $\underline{1306-C(a)(3)}$ or (b).

- 10 Section 2. Sections 1302-C(b)(2), 1305-C(a), 1306-C, 1313-
- 11 C(a.1)(2) and 1314-C(b) AND (C)(3) of the act, amended July 2,

- 15 (b) Appointment.--
- 16 * * *
- 17 (2) The judge may, at the request of the school entity
- or nonpublic school, grant the school police officer the
- powers as provided under section 1306-C(b), the authority to
- issue citations for summary offenses as provided in section
- [1306-C(3)] 1306-C(a)(3) or the authority to detain students
- 22 until the arrival of local law enforcement or any combination
- thereof.

- 25 Section 1305-C. Training.
- 26 (a) General rule. -- A school police officer who has been
- 27 granted powers under section [1306-C(3)] 1306-C(a)(3) or (b) or
- 28 has been authorized to carry a firearm must, before entering
- 29 upon the duties of the office, satisfy the following:
- 30 (1) Successfully complete basic training as required by

- 1 the Municipal Police Officers' Education and Training
- 2 Commission under 53 Pa.C.S. Ch. 21 Subch. D (relating to
- 3 municipal police education and training) or has graduated
- from the Pennsylvania State Police Academy, has been employed
- 5 as a State trooper with the Pennsylvania State Police and has
- 6 separated from that service in good standing.
- 7 (2) (i) Successfully complete the Basic School Resource
- 8 Officer Course offered by the National Association of
- 9 School Resource Officers or an equivalent course of
- instruction approved by the commission.

- school <u>before September 2, 2019</u>, shall have [six months
- from the effective date of this paragraph] until the

- 18 Section 1306-C. Powers and duties.
- 19 (a) General rule. -- A school police officer appointed under
- 20 section 1302-C(b) shall possess and exercise all the following
- 21 powers and duties:
- 22 (1) To enforce good order in school buildings, on school
- buses and on school grounds in the respective school entities
- or nonpublic schools. For purposes of this paragraph, the
- term "school bus" shall include a vehicle leased by the
- 26 school entity or nonpublic school to transport students and a
- vehicle of mass transit used by students to go to and from
- school and school activities when the school police officer
- 29 responds to a report of an incident involving a breach of
- 30 good order or violation of law.

- 3 buildings, on school buses and on school grounds in the

- 6 (b) Specific powers.--If authorized by the court, a school
- 7 police officer who is a law enforcement officer employed by a
- 8 <u>school entity or nonpublic school whose responsibilities</u>,
- 9 <u>including work hours</u>, are established by the school entity or
- 10 <u>nonpublic school</u>, <u>may exercise the same powers as exercised</u>
- 11 under authority of law or ordinance by the police of the
- 12 municipality in which the school property is located.

- 15 (a.1) Training.--
- 16 * * *
- 17 (2) A school resource officer who is [currently]
- stationed in a school entity or nonpublic school <u>before</u>
- 19 <u>September 2, 2019,</u> shall have [six months from the effective
- date of this subsection] until the beginning of the 2020-2021
- 21 school year to complete the instruction.

- 23 Section 1314-C. School security guards.
- 24 * * *
- 25 (b) Training. -- The following shall apply:
- 26 (1) [A] Prior to entering upon the duties of the office,
- 27 <u>a</u> school security guard shall successfully complete the Basic
- 28 School Resource Officer Course offered by the National
- 29 Association of School Resource Officers or an equivalent
- 30 course of instruction approved by the commission.

1	(2) [A] <u>AN UNARMED</u> school security guard who is <-
2	[currently] employed or contracted by a school entity or
3	nonpublic school <u>before September 2, 2019</u> , shall have [six
4	months from the effective date of this subsection] until the
5	beginning of the 2020-2021 school year to complete the

8	(3) AN ARMED SCHOOL SECURITY GUARD WHO IS EMPLOYED OR <-
9	CONTRACTED BY A SCHOOL ENTITY OR NONPUBLIC SCHOOL BEFORE
10	SEPTEMBER 2, 2019, SHALL HAVE UNTIL FEBRUARY 28, 2020, TO
11	COMPLETE THE INSTRUCTION UNDER PARAGRAPH (1) UNLESS AN
12	EXTENSION IS APPROVED THROUGH THE FOLLOWING PROCESS:
13	(I) THE GOVERNING BODY OF A SCHOOL ENTITY OR
14	NONPUBLIC SCHOOL MAY APPROVE AN EXTENSION OF THE DEADLINE
15	SPECIFIED IN THIS PARAGRAPH FOR ARMED SCHOOL SECURITY
16	GUARDS TO COMPLETE THE REQUIRED INSTRUCTION DUE TO A

2	15 DAYS FROM THE DATE OF APPROVAL. ANY DOCUMENTATION
3	SUBMITTED UNDER THIS CLAUSE MAY NOT BE SUBJECT TO THE

9	VISITORS DUE TO THE ABSENCE OF SCHOOL SECURITY GUARDS
10	WHILE SCHOOL IS IN SESSION BECAUSE OF COMPLIANCE WITH
11	THE INSTRUCTION DEADLINE.
12	(B) DEPLOYMENT OR ACTIVE MILITARY SERVICE,
13	ILLNESS, FAMILY EMERGENCY, DEATH IN THE IMMEDIATE
14	FAMILY OR OTHER APPROVED LEAVE OF ABSENCE WHICH WOULD
15	PREVENT SCHOOL SECURITY GUARDS FROM COMPLYING WITH
16	THE INSTRUCTION DEADLINE.
17	(C) ARMED SCHOOL SECURITY GUARDSA SCHOOL ENTITY OR
18	NONPUBLIC SCHOOL MAY EMPLOY OR CONTRACT WITH AN INDEPENDENT
19	CONTRACTOR OR A THIRD-PARTY VENDOR UNDER SECTION 1311-C FOR AN
20	ARMED SCHOOL SECURITY GUARD IF ALL OF THE FOLLOWING CONDITIONS
21	ARE MET:

30	(d) (1) Beginning with students graduating from a public

- 1 high school at the end of the 2020-2021 school year, and
- 2 continuing in each school year thereafter, a student who
- 3 successfully completes a course in personal finance during
- 4 grades nine through twelve shall be permitted to apply up to one
- 5 credit earned for successful completion of the course to satisfy
- 6 the student's social studies, family and consumer science,
- 7 <u>mathematics or business education credit requirement for</u>
- 8 graduation, provided that the governing body of the student's
- 9 <u>public high school shall have discretion to determine the</u>
- 10 graduation credit requirement to which the credit earned by the
- 11 <u>student shall be applied.</u>
- 12 (2) A student shall not be permitted to apply more than one

- 22 other factors that may assist an individual in this Commonwealth
- 23 to be financially responsible.
- 24 "Public high school" shall mean a public school, including a
- 25 school within a school district, a charter school, a cyber
- 26 charter school, a regional charter school or a career and
- 27 <u>technical school</u>, that offers twelfth grade.
