## AN ACT

Amending the act of December 5, 1936 (2nd Sp.Sess., 1937 P.L.2897, No.1), entitled "An act establishing a system of 2 unemployment compensation to be administered by the 3 Department of Labor and Industry and its existing and newly 4 created agencies with personnel (with certain exceptions) 5 selected on a civil service basis; requiring employers to keep records and make reports, and certain employers to pay 6 7 contributions based on payrolls to provide moneys for the 8 payment of compensation to certain unemployed persons; 9 10 providing procedure and administrative details for the determination, payment and collection of such contributions 11 and the payment of such compensation; providing for 12 cooperation with the Federal Government and its agencies; 13 creating certain special funds in the custody of the State 14 Treasurer; and prescribing penalties," in administration of 15 act, further providing for the Unemployment Compensation 16 Board of Review. 17 18 The General Assembly of the Commonwealth of Pennsylvania 19 hereby enacts as follows: 20 Section 1. Section 203(a) of the act of December 5, 1936 21 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as the Unemployment 22 Compensation Law, is amended to read: 23 Section 203. Unemployment Compensation Board of Review. -- (a) 24 (1)There is hereby created in the department an Unemployment

Compensation Board of Review.

- 1 (2) The board shall consist of three members nominated and
- 2 appointed by the Governor, by and with the advice and consent of
- 3 two-thirds of all the members of the Senate, for terms of six
- 4 years each, and until their successors shall have been appointed
- 5 and qualified[, except that the terms of the members first
- 6 taking office shall expire on July first, one thousand nine
- 7 hundred thirty-nine; July first, one thousand nine hundred
- 8 forty-one; and July first, one thousand nine hundred forty-
- 9 three, respectively, as designated by the Governor at the time
- 10 of appointment and until their successors shall have been
- 11 appointed and qualified].
- 12 (3) Each member shall devote full time to official duties
- 13 and may not hold any office or position the duties of which are
- 14 <u>incompatible with the duties of the office of board member nor</u>
- 15 be engaged in any business, employment or vocation for which the
- 16 member receives remuneration, but a member may speak, write or
- 17 <u>lecture if reimbursed expenses, honorariums, royalties or other</u>
- 18 money received in connection with the activities are disclosed.
- 19 (4) Each member must be an attorney at law and have at least
- 20 five years of practice as an unemployment compensation referee
- 21 or other administrative hearing officer, five years of practice
- 22 before administrative agencies or equivalent experience.
- 23 <u>(5)</u> The Governor shall designate one of the members as
- 24 chairman.
- 25 (6) Vacancies [in said board] shall be filled for the
- 26 unexpired terms. [The chairman of the board shall receive a
- 27 salary at the rate of nine thousand dollars per annum. The other
- 28 members of the board shall receive salaries at the rate of eight
- 29 thousand five hundred dollars per annum.]
- 30 (7) The chairman of the board shall receive a salary

- 1 equivalent to the salary of the chairman for the Workers'
- 2 Compensation Appeal Board, as set by the Executive Board. The
- 3 <u>other members shall receive salaries equivalent to the salaries</u>
- 4 of the members of the Workers' Compensation Appeal Board, as set
- 5 by the Executive Board. Such salaries shall be paid from the
- 6 Administration Fund.
- 7 (8) Two members of the board shall be a quorum, and no
- 8 action of the board shall be valid unless it shall have the
- 9 concurrence of at least two members. A vacancy on the board
- 10 shall not impair the right of a quorum to exercise all the
- 11 rights and perform all the duties of the board.
- 12 \* \* \*
- 13 Section 2. This act shall apply as follows:
- 14 (1) The addition of section 203(a)(3) of the act shall
- apply to members who are appointed before, on or after the
- 16 effective date of this act.
- 17 (2) The addition of section 203(a)(4) and (7) of the act
- 18 shall apply to members who are appointed on or after the
- 19 effective date of this act.
- 20 Section 3. This act shall take effect immediately.
